5. That the Higher Educational Institution shall not offer any of the prohibited programmes i.e. programmes not permitted to be offered in Open and Distance Learning Mode and Online mode in Higher Education as mentioned in clause (z) of Regulation 2 of University Grants Commission (Open and Distance Learning Programmes and Online Programmes) Regulations, 2020.
6. That the Higher Educational Institution shall provide all such information as asked by UGC and display the same information as per mandatory disclosure of information as stipulated under Regulation 9 of the University Grants Commission (Open and Distance Learning Programmes and Online Programmes) Regulations, 2020.
7. That while complying with University Grants Commission (Open and Distance Learning Programmes and Online Programmes) Regulations, 2020, the compliance to other relevant UGC Regulations and norms issued by the other statutory/regulatory bodies from time to time shall also be ensured.
8. That the Higher Educational Institution shall ensure adherence to four quadrants approach in all courses of all programmes and also all other requirements as envisaged in the UGC (Open and Distance Learning Programmes and Online Programmes) Regulations, 2020.
9. That the Higher Educational Institution shall ensure the readiness/availability of E- Learning Material for all years/semesters of proposed programmes and its uploading on the learning platform before the start of academic session. Information about the same shall be intimated to UGC in timely manner.
10. That the Higher Educational Institution shall upload admission details on the portal (<https://deb.ugc.ac.in>) within the stipulated time as notified by the Commission from time to time.
11. That the Higher Educational Institution shall provide the details of all International learners enrolled immediately after the beginning of the academic session to the Ministry of External Affairs, Ministry of Education and University Grants Commission.

That the deponents are fully aware that in case any information, documentary evidence submitted/produced by the Higher Educational Institution is found to be false or fake at a later stage or in case of any violation, the UGC shall take punitive measures as mentioned in University Grants Commission (Open and Distance Learning Programmes and Online Programmes) Regulations, 2020.
